PUBLIC COMMENTS:

1. PRESENTATIONS:

- a) **Recognition of Deputies David Waldbauer and Brendan Caraway in Appreciation for their Dedicated law Enforcement Services to the Citizens of the City of Hughson (CC) Rasmussen**

Chief Rasmussen and Mayor Bawanan presented Certificate of Appreciation to Deputies David Waldbauer and Brendon Caraway thanking them for their dedicated service to the City of Hughson.

- b) **Presentation from CEO Bill Bassitt of the Stanislaus Economic Development and Workforce Alliance (CC) Bill Bassitt**

Bill Bassitt provided information faced with the real tragedy of unemployment in Stanislaus County and the State. He provided background information on the formation and services provided through the Workforce Alliance. Mr. Bassitt discussed the benefits to small businesses and cities throughout the County area and their accomplishments in working with existing and attracting new businesses. He provided an overview of the challenges facing the economic growth and lacking resources, the need to aggressively market, retain existing businesses and the need to provide resources. He noted the obligations they have to better prepare the communities to put people back to work. The Alliance has profession staff to put together the strategies to face those challenges. He requested Council enter into a cooperation agreement with the Alliance to evaluate the community buying tendencies and finalizing the strategy in Hughson. This would tell those looking to relocate where the citizens are spending their dollars and allow the information used to attract new businesses.

Mr. Bassit will schedule a meeting with the City Manager and the Mayor to present a strategy to utilize the Workforce Alliance in cooperation with the City of Hughson.

Council Member Beekman asked about incubator businesses. Mr. Bassett explained that those incubators provide the needs of the business without the impact of full cost that could financially affect a business just starting out. This type of business provides businesses with protection from the real costs of doing business. He briefly discussed public grants that would assist those types of businesses.

Mr. Bassitt discussed the services provided by the Senior Core of Retired Executives (SCORE). This agency is willing to help businesses at no charge. SCORE has indicated that they are willing work with the Alliance to develop a business plan and to work with the local businesses before they start their business, projecting information to assure that the business would succeed.

Council Member Carr requested Item B pulled for further discussion

He questioned the water developer impact fees. City Manager Whitemyer explained that the deficit reflects a cash flow issue, explaining that funding from the State will be reimbursed once the City files the claims for reimbursement for the project. He noted that Well #8 project is complete and once the City pays the Contractor, the City will be reimbursed that cost, which will be reflected in the budget at that time. City Manager explained that due to the time limitation of the report, that the Treasurer's report was not completed. However, in the future, the Treasurer's report will include justification of that report as submitted to Council. Council Member Beekman questioned the Transportation cash flow. City Manager Whitemyer explained that staff is reviewing the process of auditing those funds, which will be provided when the funds are identified.

CITY BUSINESS - CONSIDER THE FOLLOWING:

- 3. Adopt a Joint Resolution 2011-007/RDA 2011-001 Opposing the Governor's Proposal to Abolish Redevelopment Agencies in California** (CC/RDA) Whitemyer

Recommendation: By motion adopt Resolution 2011-007/RDA 2011-001 Opposing the Proposed State Action to Abolish Redevelopment Agencies and Authorize City Council and Staff to Communicate its opposition to the Governor's Proposal.

City Manager Whitemyer presented the report to Council. He outlined the Governor's proposal to abolish the Redevelopment Agency and requested Council adopt the Resolution as recommended and authorize staff to present a letter of opposition as proposed.

He noted that Economic Development is the key to the success of the State and the RDA pays a huge factor in this success. If abolished, this would eliminate the City's opportunity to go forward with the 48 unit housing project and future building would not continue. City Manager Whitemyer explained that if the Governor succeeds in the elimination of the Redevelopment Agency, will remove future tools needed for Redevelopment and the Economic Development with Hughson and will also create huge increases to the General Fund Expenditures which could be a dire impact to the City.

ACTION: Council member Beekman motioned to adopt Resolution 2011-001 by title only, seconded by Council Member Carr. Council Members: Young, Beekman, Silva, Carr and Mayor Bawanan. Motion Carried: (5-0) Resolution 2011-001 Adopted.
